## GDC Role in Public Safety: Judges



#### Make important and informed bond decisions

- Felonies pending preliminary hearing + Class 1 & 2
  Misdemeanors
- Judiciary relies on Court Services' information as to threat, flight risk, effectiveness of prior services
- Bond and/or supervision in lieu of incarceration
- Improves access to services, can maintain employment and family obligations
- Improves outcomes



## GDC Role in Public Safety: Judges



#### Judicial oversight

- Clerk's Office executes order and provides extensive customer service to citizens
- Court Services monitors compliance with order and promptly notifies Judge of alleged violations
- Improved outcomes



Initiative: Supervised Release Program (SRP) violation review docket

- ✓ Many Diversion First clients
- ✓ CSB present
- ✓ Judge reviews SRP report and recommendations from CSB, Commonwealth's Attorney and Defense Attorney
- ✓ Judge can prod client to get services and can revoke bond



# GDC Role in Public Safety: Judges



#### Adjudicate cases in a fair and timely fashion

- Justice delayed is justice denied
- Expedited and reduced number of hearings
- Less time incarcerated
- Improved citizen outcomes



Initiative: DWI Arraignment & Information on Attorney Dates

✓ Reduce number of hearings to expedite case resolution



Initiative: Felony Preliminary Hearing Update

✓ Reduce number of continuances to expedite case resolution after stakeholder meetings

# Effective and informed sentencing reduces recidivism

- Judiciary relies on record of prior effective services
- Commonwealth's Attorney and Defense Attorney are more informed of pertinent circumstances
- Craft effective sentencing
- Improve outcomes



Initiative: Supervised Release Program (SRP) Reports

- ✓ Probation Officer and CSB prepare summary report
- ✓ Commonwealth's Attorney and Defense Attorney review and craft more effective sentences

#### Judicial oversight

✓ Existing program: Probation Violation Review





# Conducts criminal record checks for courts, Police, Magistrate, others

- Provides critical information
- Improves bond and release decisions
- Allows police to return to street more quickly
- Improves outcomes

Investigates incarcerated defendants and makes bail/release recommendations to the judiciary

- Evidence based
- Critical to Judiciary to make informed bond decisions
- Assigns legal counsel to indigent defendants
- Improves outcomes




#### Provides intensive supervision (Diversion First)

- Alternative to incarceration
- Improves access to services
- Can maintain employment and family obligations
- Identification of mental health needs early in process
- Expedites access to services
- Reduces recidivism
- Improves outcomes
















#### Provides pretrial supervision

- Alternative to incarceration
- Improves access to services, can maintain employment and family obligations






81% growth since FY 2014







## GDC Role in Public Safety: Probation



#### Provides standard probation supervision

- Alternative to incarceration
- Post-trial supervision
- Improves access to services, can maintain employment and family obligations
- Reduces recidivism
- Improves outcomes



## GDC Role in Public Safety: Probation



Assists probationers with requirements of driver's license reinstatement (Driving on Suspended Program)

- Post-trial supervision
- Reduces recidivism
- Improves outcomes



Supervises qualified Veterans seeking treatment (Veterans Treatment Docket)

- Structured for military service members with mentor component
- Reduces recidivism
- Improves outcomes

## GDC Role in Public Safety: Probation



# Supervises qualified alcohol offenders (Alcohol Diversion Program)

- For young adult population, client in the community
- Similar to restorative justice
- Reduces recidivism
- Improves outcomes



#### GDC Role in Public Safety: Other Services



#### Assigns court appointed attorneys



Provides legal representation to qualified indigent defendants

#### Assigns foreign language interpreters

Improves access to justice for non-English speaking population



#### Manages Volunteer & Intern Program

- Assists court and is cost effective
- Assists citizens in courthouse
- Connects community to the court

#### Use of validated instruments

- Pretrial defendants and post-trial offenders
- Race and gender neutral
- Informed judiciary of risk level to improve bail and sentencing decisions

# Challenges



- Lack of Probation Officers to provide community supervision
- Courthouse office space to provide confidential client meetings
- Services to meet needs of programs
- Unfunded state mandates
