Presentation by the CSB

Mr. Washington gave a PowerPoint slide presentation regarding the CSB data update.

- Addressing mental health crisis in the community
- Consideration on staffing issues
- Outreach with neighboring colleges to find students interested in community mental health
- Ability to pay model and maximization of billing for services
- The surge in services at the State level

- Ability to recruit and maintain qualified staff to meet the service delivery goal
- Financial impact
- Influx of people seeking service and the impact of staffing vacancies
- Creative ideas to review pay
- Periodic report to the Board on staff vacancies and issues
- Plans to identify and provide triage and telehealth to manage risk levels on crisis standpoint
- Pilot and update on the co-responder model
- Preparing to handle the surge
- The opioid epidemic and Narcan and the differences between incidents and the number of people
- Treatment options and challenges for the opioid epidemic
- Update on what the school system is doing in terms of the opioid training and the curriculum
- Future needs and looking at intervention and ideas to consider for staffing
- Plans to hire more people and timeline to review data
- Working with Department of Human Resources to come up with hiring bonuses and job share for those who want to work part time
- Transitioning positions into those needed to handle the surge
- Problems accessing crisis residential services for individuals with Intellectual Disability and Mental Health issues
- Low pay for attendants at the residential homes
- Flexibility in the budget to look at the pay to meet the needs of the community when required
- Availability of funds and resources to support the CSB in its work

• Access to services for the youth and at-risk kids throughout the year
