Culmore partners is a network of nonprofits, faith-based groups, residents, government agencies and businesses.
- Liaison Johnson presented a copy of the bedbug disclosure form New York City landlords are required to provide to new tenants. This requirement, which became effective under the New York City Housing Maintenance Code (Section 27-2018.1) on August 30, 2010, informs tenants of any infestation history for the previous year. Commissioners discussed the need for such a disclosure for the tenant-landlord community in Fairfax County. It was requested that staff research current disclosure laws for tenants in Virginia for continued discussion at the November meeting.

- Commissioner McEnearney requested a summary regarding the county's budget. Director Liberman will arrange for the viewing of *Juggling in a Struggling Economy: The FY 2012 Budget Process*.
