IT APPEARING that Ms. Mena is an attorney in good standing with the State of New York; and

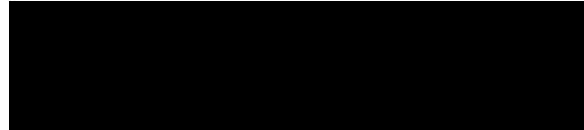
IT APPEARING that there is no objection to such admission; and

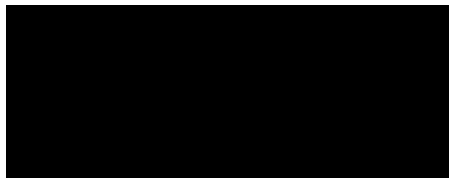


