Subject: Stormwater Management Ordinance Procedures for Requesting Grandfathered Projects and Time Limits Determinations

Date: March 24, 2014 No.: 14-06

Summary: Additional guidance regarding the Time Limits on Applicability of Approved Design Criteria and Grandfathering provisions of the Stormwater Management Ordinance, Chapter 124 of the County Code (Ordinance).

Effective Date: Immediately.

Background: On January 28, 2014, the Fairfax County Board of Supervisors adopted the new Ordinance and related amendments to the Public Facilities Manual (PFM), as well as amendments to other chapters of the County Code. The new Ordinance and related amendments implement the Virginia Stormwater Management Act (Va. Code Ann. § 62.1-44.15:24, et seq.) and Virginia Stormwater Management Program (VSMP) Regulation (9VAC25-870 et seq.). The Ordinance becomes effective July 1, 2014. The provisions in §124-1-11 (Time Limits on Applicability of Approved Design Criteria) that address land-disturbing activities with existing general permit coverage, and the provisions in §124-1-12 (Grandfathering) are mandated by the state regulations.

On February 19, 2014, the County issued Technical Bulletin No. 14-04, together with the detailed guidance document titled, "*Guidelines for Implementing Grandfathering or Time Limits on Applicability of Approved Design Criteria for the Stormwater Management Ordinance of Fairfax County*" (Guidelines). The intent is that the Guidelines will serve as the foundation for the implementation of the "Time Limits" and "Grandfathering" provisions. However, recognizing that the Ordinance and Guidelines may not sufficiently address every situation, the County has prepared a list of approved plans that includes a preliminary determination whether or not they appear to meet the conditions for Grandfathering or Time Limits.

The document titled, "*Preliminary Determination of the Status of Active Plans under the Grandfather and Time Limits Provisions of the Stormwater Management Ordinance*" is provided to facilitate the determination of grandfathered plans. The attached lists were compiled, with the intent of identifying only active plans, from plans tracked in the County Plans and Waivers System (PAWS) for the period July 1, 2010, through March 12, 2014. Disapproved plans in PAWS are not included in the list because it is not possible to determine if and when the plans will be resubmitted.

Preliminary Subdivision Plats are listed as grandfathered if they were approved prior to July 1, 2012. No attempt was made to determine if the plats remain valid under the Subdivision Ordinance.

Subdivision and Site Plans are listed as grandfathered if they have a grandfathered Preliminary Subdivision Plat or a Rezoning/Special Exception/Special Permit approved prior to July 1, 2012, that includes a layout of the stormwater management facilities and associated computations. Generally, zoning applications submitted after July 1, 2004, and approved prior to July 1, 2012, were considered to have met this requirement. July 1, 2004, is the date that the current submission requirements for zoning applications related to stormwater management became effective. The submission requirements for zoning applications parallel the provisions in the Ordinance for a plan to be grandfathered. Not all of the zoning applications were fully reviewed to determine if the submission requirements had, in fact, been met, although the vast majority of plans were checked. Public projects were grandfathered if they are included in the FY2013 – FY 2017 Capital Improvement Program approved by the Board of Supervisors.

Subdivision and Site Plans are listed as Time Limits if they have state permit coverage. Site and Subdivision Plans that otherwise could have been grandfathered lose that status if construction starts or state permit coverage is obtained before July 1, 2014. The County's inspection database was used to determine which projects have begun construction. Permit coverage was determined using the Department of Environmental Quality's online database, which can be found at: www.deq.state.va.us/Portals/0/DEQ/Water/StormwaterManagement/CGP_ACTIVE_WEB.xlsx.

Subdivision and Site Plans listed without a check in either the Grandfathered column or Time Limits column do not meet the applicable criteria, and do not have Grandfathered or Time Limits status. Please note that a plan's status is not static and may change over time. For example, a non-grandfathered plan that is approved and obtains permit coverage prior to July 1, 2014, would then be covered under the Time Limits provisions.

<u>Guidance Lists</u>: Preliminary Determination of the Status of Active Plans under the Grandfather and Time Limits Provisions of the Stormwater Management Ordinance lists, attached, are separated into three groups:

- 1. Preliminary Subdivision Plats,
- 2. Subdivision Plans, and
- 3. Site Plans.

Applicants interested in their plan's grandfathering status should review the lists, recognizing that it is a preliminary determination made without a full review of the plan, and verify the plan's status based on code requirements. If an applicant has reason to believe that the designation of a plan on the list is not correct or a plan does not appear on the list, then the applicant may request that the County review a specific plan and issue a written determination.

Procedures: An applicant may submit a request for a determination whether a specific, previously approved and currently valid plan meets the criteria of the Time Limits or Grandfathering provisions in the Ordinance. Requests must include sufficient information for review, including, but not limited to:

- 1) A request letter, including:
 - a) Applicant name, address and contact information,
 - b) Citation of the specific provision of the Ordinance forming the basis of the request,

- c) Description of the project, including name, location, tax map number, County plan number, date of approval, and details of the development, such as size and scope, and
- d) Statement of justification, including a narrative demonstrating compliance with all the criteria of the applicable Ordinance provision.
- 2) Supporting documentation and information as needed, based on the applicable provision:
 - a) For "Time Limits" determination requests per §124-1-11.A, provide evidence that initial coverage under the State General Permit was obtained prior to July 1, 2014 (i.e., DEQ coverage letter showing VSMP number and date issued).
 - b) For "Grandfathered" private project determination requests per §124-1-12.A,
 - i) Provide the relevant portions of the currently valid proffered rezoning or P district rezoning or other rezoning with a plan of development, special exception, special permit, variance, preliminary or final subdivision plat, subdivision construction plan, preliminary or final site plan, or grading plan that was approved by the County prior to July 1, 2012 ("Prior Approved Plan"), including:
 - (1) Coversheet, or other suitable documentation (e.g., Clerk's letter), showing date of approval was prior to July 1, 2012;
 - (2) Layout (a conceptual drawing that identifies the location of the proposed stormwater management facilities required at the time of approval);
 - (3) Pre- and post-development calculations that detail the required pollutant reduction necessary to comply with the water quality design criteria provided with the Prior Approved Plan; and
 - (4) Calculations necessary to determine compliance with the water quantity design criteria provided with the Prior Approved Plan.
 - ii) Optional: In addition to the Prior Approved Plan, one detailed proposed development layout may be submitted for review, demonstrating that the proposed development has not been modified or amended in a manner resulting in an increase over the previously approved plat or plan in the amount of phosphorus leaving each point of discharge or the volume or rate of runoff.
 - c) For "Grandfathered" local, state or federal ("public") project determination requests per §124-1-12.B,
 - i) Provide relevant information for the project, either;
 - (1) Evidence of the local, state or federal funds specifically obligated prior to July 1, 2012, for the project, or
 - (2) A copy of the Stormwater Management Plan approved by the Department of Conservation and Recreation prior to July 1, 2012.
 - d) For "Grandfathered" local, state and federally funded project determination requests per §124-1-12.D, provide evidence of the governmental bonding or public debt financing, issued prior to July 1, 2012, for the project.

It is important to present the information in the determination request in a clear and concise manner. Clear references to the supporting plans and documents including sheet numbers are recommended to facilitate timely review by staff.

Requests may be submitted to the Site and Addressing Center, DPWES, 12055 Government Center Parkway. A new plan type, Stormwater Management Ordinance Determination (SWOD), will be created in PAWS. An applicant may track the review of such requests online though the Land Development System at <u>http://ldsnet.fairfaxcounty.gov/ldsnet/</u>. There is no review fee for these requests at this time.

Staff will endeavor to respond to all requests as quickly as possible. However, please note that individual response times will vary depending on the overall number of requests received, the complexities of the particular situation, and/or whether additional coordination with the Virginia Department of Environmental Quality (DEQ) is deemed necessary.

The SWOD requests allow for determination of the project's grandfathering status in advance of formal plan submission; however, in lieu of a separate determination request, applicants may elect to include the determination request in the plan or as an attachment to a plan submission. In order to facilitate effective plan review, it is requested that all the supporting information described above be included with all such requests.

Land-disturbing activities that are not exempt from the Ordinance, and that either do not have coverage under the state General Permit for Discharges of Stormwater from Construction Activities prior to July 1, 2014, or do not meet the criteria for Grandfathering, must comply with the new technical requirements contained in Article 4 of the Ordinance. The Ordinance does not prevent an applicant from designing to a more stringent standard if they choose to do so, or are committed to do so by a proffer.

This document is intended only as guidance and not as a substitute for the actual text of the code. Please note that the information contained in the Guidelines and this technical bulletin is based on staff's current understanding of the regulatory intent of the grandfathering and time limits provisions of the state regulations. Subsequent regulatory changes and/or additional regulatory guidance from DEQ could affect the content of the Guidelines and this document. The County will update these policies and procedures if necessary.
