**LITTLE HUNTING CREEK FORCE MAIN
PROJECT NO. WW-000007-007-A**

Sealed bids are hereby solicited for construction of the **Little Hunting Creek Force Main** located beginning at the Little Hunting Creek Pump Station at 8600 Thomas Stockton Parkway, Alexandria, and ending at a discharge chamber across from 8802 Surrey Court, Alexandria. The project consists of installation of approximately 5,170 linear feet of 36-inch, 30-inch, and 24-inch sanitary sewer force main, comprised of approximately 3,317 linear feet of 30-inch and 24-inch ductile iron pipe installed via open-cut method and approximately 1,853 linear feet of 36-inch high-density polyethylene (HDPE) pipe installed via horizontal directional drill; and all other Work required in accordance with the Contract Documents.

Only firms that have been pre-qualified will be eligible to submit bids for this project. Bids received from those that have not been pre-qualified will not be considered.

This is a **lump sum** price contract. Contract length is **395** calendar days.

Bids will be received in the office of the Director, Wastewater Design and Construction Division, Department of Public Works and Environmental Services, 12000 Government Center Parkway, Suite 449, Fairfax, Virginia until **10:30 a.m.**, prevailing local time, **WEDNESDAY, JUNE 12, 2024**.
