
CSB Afterschool Tutor

Board of Supervisors Meeting:

The Board of Supervisors will meet on **Tuesday, January 14, 2020** at 9:30 a.m. at the Fairfax County Government Center (12000 Government Center Parkway, Fairfax, VA 22035) in the Board Auditorium. The meeting will be broadcast live on <u>Channel 16</u>. There are three Sully District applications on the <u>agenda</u>. More information about these applications is below.

PCA 84-S-038-02 (Dominion Electric Supply Company, Inc.) -

The applicant (Dominion Electric Supply Company, Inc.) is proposing to amend PCA 84-S-038, previously approved for warehousing with associated office and retail uses, to permit modifications to the approved proffers and site design. County staff recommends approval of PCA 84-S-038-02, subject to the proffers contained in Appendix 1 of the <u>Staff Report</u>. The Planning Commission recommends approval of PCA 84-S-038-02, subject to the <u>proffers</u> dated October 18, 2019. The Planning Commission Verbatim Excerpt is available online.

Public Hearing to Consider the Conveyance of Board-owned Property -

The Board of Supervisors is the owner of three parcels located near the intersection of Lee-Jackson Memorial Highway (Route 50) and Fair Ridge Drive. The vacant parcels, totaling approximately one acre, are the residue of the land incorporated into the West Ox Road/Route 50 interchange.

The Fairfax County Redevelopment and Housing Authority (FCRHA) is evaluating the possibility of partnering with a private developer pursuant to the terms of the Public-Private Education Facilities and Infrastructure Act of 2002 (PPEA), or through other development means, to construct affordable housing units on the Property. The creation of a new housing development for individuals with low to moderate incomes (the Project) anticipates a rezoning approval.

County staff recommends that the conveyance of the Fair Ridge Properties to the FCRHA be subject to the condition that the parcels must be used in connection with the Project. In the event the FCRHA no longer pursues the Project, the Authority will transfer ownership of the properties back to the Board.

*SE 2019-SU-016 (Sadaf Azhar Rashid Khan) -

This property is located at 13967 Endeavour Drive, Herndon, VA 20171 in the Sully District. The applicant (Sadaf Azhar Radhid Khan) is proposing to permit a home child care facility for up to 12 children at any one time. County staff recommends approval of SE 2019-SU-016, subject to the proposed development conditions contained in Appendix 1 of the Staff Report. The Planning Commission recommends approval of SE 2019-SU-016, subject to proposed development conditions dated November, 26, 2019. The Planning Commission Verbatim Excerpt is available online. *This case is being deferred to a date to be determined later.

RZ/FDP 2019-SU-009/PCA 78-S-063-09/PCA 85-S-061-06/PCA 85-S-039 (Elm Street Communities, Inc.) -

The applicant (Elm Street Communities, Inc.) is proposing three PCAs to delete land area from Westfields rezoning and rezone to the PHD-8 District to permit development of 157 single family attached dwelling units. County staff recommends:

- Approval of RZ 2019-SU-009 and the associated Conceptual Development Plan (CDP), subject to the execution of proffers consistent with those included in Appendix 1 of the <u>Staff Report</u>.
- Approval of the Final Development Plan (FDP) 2019-SU-009, subject to the development conditions contained in Appendix 2 of the <u>Staff Report</u>.
- Approval of PCA 78-S-063-09 to remove the subject property from RZ 78-S-063.
- Approval of PCA 85-S-061-06 to remove the subject property from RZ 85-S-061.
- Approval of PCA 86-S-039 to remove the subject property from RZ 86-S-039.
- Approval of the following modifications in association with RZ/FDP 2019-SU-009: Modification of Par. 2 of Sect. 6-207 of the Fairfax County Zoning Ordinance to modify the minimum 200 square foot privacy yard for each single-family attached dwelling as shown on the CDP/FDP. Modification of Par. 2 of Sect. 11-302 of the Fairfax County Zoning Ordinance to permit private streets in the proposed development to exceed the maximum 600-foot length limitation as shown on the CDP/FDP.

FCPS Announces Proposed FY 2021-2025 Capital Improvement Program (CIP)



Fairfax County Public Schools (FCPS) has released its <u>proposed FY 2021-25 Capital Improvement Program</u> (CIP), reflecting a five-year requirement of over \$1 billion. FCPS continues to experience uneven growth throughout the division because of changes in population, new development, and net migration. In certain areas, membership is projects to exceed the ability to accommodate students within existing buildings.

The 2019 School Bond Referendum recently approved by county voters provided funding for the construction of one new elementary school, the relocation of one modular addition, construction of three high school additions, and renovations of five elementary schools and two middle schools. The bond also included funding for the planning of one new elementary school and the renovations of five elementary schools.

The School Board will hold a public hearing on the FY 2021-25 CIP on Monday. January 27, 2020 at 5:30 p.m. in the auditorium of Luther Jackson Middle School. Please note this public hearing was rescheduled due to inclement weather, and if you were registered to speak at the January 7 Public Hearing you do not have to register again.

Stalking is:

- repeated and unwanted contact that makes you feel afraid or harassed
- serious, often violent, and can escalate over time
- a crime in all 50 states and the District of Columbia

Stalking is common:

- Six million to 7.5 million people are stalked in a one-year period in the United States.
- Nearly 1 in 6 women and 1 in 17 men are stalked during their lives.
- Most people who are victims of stalking are stalked by someone they know, including a current or former romantic partner.

Ellanor C. Lawrence Park FAQs

1. Are there rattlesnakes and water moccasins here?

No. The only venomous <u>snake</u> in Fairfax County is the northern copperhead.

2. Are there coyotes here?

Yes. Coyotes are becoming more common in Fairfax County, and they have been seen and photographed at E.C. Lawrence Park. They generally pose no threat to humans.

- 3. I saw a fox in broad daylight and he didn't run. Does that mean he has rabies?

 No. Although foxes and coyotes are chiefly nocturnal, they are still seen during the day.

 Never approach a wild animal, and please report any out of the ordinary behavior.
- Can I take a few tadpoles home for my kids to watch grow?
 No. Park rules do not allow removal of animals or other resources from parks.
- 5. I have a critter living under my house. How do I get it out of there?
 The best way to handle wildlife around your house is to leave it alone if possible.
 Generally, animals will leave on their own after a while.
- Should I use mothballs to get rid of animals?
 No. Mothballs are poisonous. They harm the environment and put children and pets in danger.
- 7. What does <u>poison ivy</u> look like?
 Poison ivy has three leaves and a hairy vine. The middle leaf has a slightly longer stem than the other two. The veins in the leaves alternate. The leaf edges may have a few coarse teeth.
- 8. <u>Beavers</u> are cutting down trees. Are you going to do anything about it?

 Beavers are a part of the park's ecosystem. We let nature take its course whenever possible. A leaning tree that appears to be dangerous should be reported to park staff.
- Can you <u>fish</u> at the pond?
 Yes. Fishing is allowed at Walney Pond. You do need a proper <u>state fishing license</u>.
- Do <u>ticks</u> from the park carry Lyme disease?
 Yes, they can. Staying on trails and using insect repellent will reduce your risk to tick exposure.
